From The President:

Great things are happening at Star Ranch!! With the annual Shareholder's meeting coming up later this month, I thought it might be a good time to pause for a moment and celebrate everything we've accomplished by working together over these past many months. I'll try to hit just some of the highlights.

-Two new professional-quality pickleball courts are complete and ready for play! And, best of all, this project was financed 100% by member donations!! Permanent fencing will soon follow.

-Two new handicapped parking spaces at Tara Hall for our disabled members and visitors. Again, 100% financed by our generous members!

-Our new treasurer along with our G.M. have our books in the best shape they've ever been! This means we can be confident in the financial health of the ranch and can share meaningful reports at each board meeting. This will also allow us to do more accurate budgeting.

-We've significantly reduced our debt! The office building is paid off, the line of credit is paid off and the last remaining consolidation loan, which was once over \$250,000, is now well less than \$50,000!

-We're sprucing things up! We've completed a refresh of Cabins 1, 2, and 5. Visitor feedback has been very positive! Plus, we've demolished 2 abandoned mobile homes that were eyesores.

-All site holders now have new, attorney-approved leases which help protect both members and the Ranch.

-The indoor pool and hot tub are up and running after we had some unexpected foundation issues in Tara Hall. But we were able to do the repairs without incurring any debt.

-We've contracted with a professional pool service company to keep all our pools crystal clear while saving a significant amount of money on pool chemicals.

-StarCast, the official podcast for Star Ranch has over 16,000 downloads. People all over Texas, all over the U.S., and all over the world are hearing about Star Ranch! Great publicity!

-We've expanded our maintenance crew to keep the grounds looking great! Plus, our house-keeping staff is keeping our rental cabins and rooms clean and inviting for guests.

-Our office staff has been busy organizing and streamlining operations for an even better customer service experience. The office was recently painted and our Star Store is stocked with an expanded line of cool items!

-We're setting records for the number of runners in our two annual 5K races. Plus, we've contracted with a new affordable timing service for fast, accurate results which runners love!

-Star Ranch is now a certified Firewise community with special recognition from the Texas A&M Forest Service for managing our wildfire risk.

-We are constructing a new, higher tower for our fire horns to help more of the ranch hear any alerts. Plus, we now offer a free opt-in service for emergency text alerts.

-The 50-amp electrical service upgrade in The Pines is well underway. This will double the number of 50-amp RV sites which will help tremendously on busy weekends and prepare us

for future growth.

-We worked with our county commissioner to get Eely Road chip sealed for a smoother drive and far less dust!

-The Food Committee has been doing an outstanding job feeding us! We now offer more meals than ever! Plus, it's a significant source of revenue, especially on busy weekends!

With so much going on, I've undoubtedly missed a few things, but I wanted everyone to know how much you are appreciated, especially our amazing volunteers. I can't tell you how many times visitors have come up to me or to the office staff to let us know how much they are enjoying all the improvements. So, THANK YOU!!

Finally, I hope to see everyone at the Shareholders Meeting at 10am Saturday morning, April 27th. This year, we have two spots on the Board of Directors to fill. Thankfully, we have three wonderful, well-qualified candidates from which to choose. If you are a shareholder and can't be with us on the 27th, please return your proxy to the Star Ranch office in advance of the meeting by hand or by mail so that your voice can be heard.

To ensure proper communication is provided to the Council as to membership preferences in the voting of the 101 shares of stock owned by the Sahnoans, an all- members straw poll may be held up to three weeks prior to the annual stockholders meeting at which the following procedure will be followed:

All qualified members over the age of 18 will be presented a slate of known candidates. Additional candidates may be nominated by the membership during the meeting.

The candidates will give their testimonials of eligibility.

The floor will be opened for the membership to question those candidates present.

After hearing from the candidates, and asking the candidates questions, the members will vote by secret ballot for all open Board positions.

The results will be collected and counted by a three-person election committee chosen by the Council prior to the election.

Protect Your Home


7 Ways Residents Can Reduce the Risk that their Homes & Property Will Become Fuel for a Wildfire

- #1 Clear**
Clear off pine needles, dead leaves & anything that can burn from your rooflines, gutters, decks, porches, patios & along fence lines. Falling embers will have nothing to burn.
- #2 Store Away**
Store away furniture cushions, rattan mats, potted plants & other decorations from decks, porches & patios. These items catch embers and help ignite your home if you leave them outside.
- #3 Screen & Seal**
Wind-borne embers can get into homes easily through vents & other openings and burn the home from the inside out. Walk around your house to see what openings you can screen or temporarily seal up.
- #4 Rake**
Embers landing in mulch that touches your house, deck or fence is a big fire hazard. Rake out any landscaping mulch to at least five feet away.
- #5 Trim**
Trim back any shrubs or tree branches that come closer than 5 feet to the house and attachments, and any overhanging branches.
- #6 Remove**
Walk around your house and remove anything within 30 feet that could burn, such as woodpiles, spare lumber, vehicles and boats - anything that can act as a large fuel source.
- #7 Close**
If ordered to evacuate, make sure all windows & doors are closed tightly, and seal up any pet doors. Many homes are destroyed by embers entering these openings and burning the house from the inside out.
